WORKSHOP ON SHORE-BASED MARITIME SERVICES FROM THEORY TO PRACTICAL USE

The International Association of Marine Aids to Navigation and Lighthouse Authorities (IALA) in association with the Portuguese Navy Lighthouse Directorate and the Norwegian Coastal Administration, kindly supported by Kongsberg, is hosting a workshop on Shore-based Maritime Services from Theory to Practical Use in Lisbon, Portugal, from 24 to 26 May, 2016.

BACKGROUND

Maritime Service Portfolios (MSPs) are an IMO e-Navigation concept and could be described as high-level descriptions of services (technical and/or operational) to be provided. The IMO e-Navigation Strategy Implementation Plan lists 16 MSPs, but they are not yet fully defined. IALA has been heavily engaged in the development of MSPs for a range of services. There is a need to provide guidance on MSPs and MSP development to assist IALA Members in the efficient development and deployment of maritime shore-based services.

TOPICS

The workshop will facilitate the development of MSPs with a focus on the practical development of attributes and specifications, taking into account e-Navigation progress in the IMO. The workshop will enable knowledge sharing on MSPs and S-100, and the drafting of IALA documentation on shore-based maritime services. The workshop will promote operational practical MSPs in a global data specific format. The workshop will develop a roadmap for developing practical MSPs, including who does what and when, and will discuss methodology and areas of overlap between responsible stakeholders. The workshop will initiate the first draft of an IALA Guideline based on best practices.

OBJECTIVE

The objective of the workshop is to enable maritime stakeholders to understand the importance of displaying information for their maritime application in a common and specific data format. The workshop will develop a Guideline on the implementation of shorebased maritime service portfolios (MSPs) giving industry, providers of information and navigators a common product specification (language) for exchange and understanding of information, and will enable participants to get acquainted and familiar with the service attributes and methodology for developing product specifications. The workshop will develop a roadmap for the sharing of information including cooperation on the development of product specifications to avoid duplication of work. The development of a roadmap for MSP development will include responsibility table for delivery and roles. In addition, the workshop aims to start the development of a Guideline, to progress understanding of MSPs and information display with recognised data format, and to familiarise participants with the correlation between the S-100 format and other relevant data formats with MSPs.

PROCESS

The Workshop will include presentations on various aspects relevant to the shore-based maritime services. The programme includes discussion periods and also work on draft IALA documentation. The intent is that the Workshop report will contain recommendations for areas of further work.
